Any tender must be made in the Form of Tender (in prescribed form) signed by the tenderer which together with other relevant tender documents shall be enclosed in a sealed envelope and placed in the specified Tender Box located at the Sales Office from 11:00 a.m. on 18 July 2025 to 7:00 p.m. on 31 December 2025 ("Tender Closing Time").
