Only individual(s) of at least 18 years old or limited company(ies) incorporated in Hong Kong or non-Hong Kong company(ies) registered under Part 16 of the Companies Ordinance (At least one director of such limited company or non-Hong Kong company shall be natural person) shall be eligible to submit tenders.

2. Any tender must be made in the Form of Tender (in prescribed form) signed by the tenderer which together with other relevant tender documents shall be enclosed in a sealed envelope and placed in the specified Tender Box located at the Sales Office from 11:00 a.m. on 1 January 2026 to 2:00 p.m. on 30 June 2026 ("Tender Closing Time").

Tender Closing Date Time falls , the Tender Closing Date and Time will automatically be postponed to 2:00 p.m. on the next succeeding day and in respect of which no typhoon signal no.8 or above or black rainstorm warning signal is announced between 11:00 a.m. and 2:00 p.m..

3. If a tender is accepted by the Vendor, the Vendor shall send a written notice of acceptance to the successful tenderer not later than 3 working days after the day on which the Tender Closing Time falls.
