Sale of Unit A, No.27 Blue Pool Road, "23-39 Blue Pool Road" and Unit B, No.27 Blue Pool Road, "23-39 Blue Pool Road" (collectively, "Properties") by way of Tender

"藍塘道23-39"藍塘道27號A單位及藍塘道23-39"藍塘道27號B單位(統稱「物業」)透過招標方式出售

1. Only individual(s) of at least 18 years old or limited company(ies) incorporated in Hong Kong or non-Hong Kong company(ies) registered under Part 16 of the Companies Ordinance (At least one director of such limited company or non-Hong Kong company shall be natural person) shall be eligible to submit tenders. The Properties must be purchased together at the same time by tenderers who are Close Relative (as defined in the relevant tender document) or Affiliate (as defined in the relevant tender document).

只有年滿 18 歲的個人或香港註冊的有限公司或根據公司條例第 16 部註冊的非香港公司(該有限公司或非香港公司須最少有一位董事為自然人)方有資格遞交標書。該物業必須由彼此為近親(根據相關招標文件定議)或關連方(根據相關招標文件定議)的招標者於同一時間一併購買。

2. Any tender must be made in the Form of Tender (in prescribed form) signed by the tenderer which together with other relevant tender documents shall be enclosed in a sealed envelope and placed in the specified Tender Box located at 18th Floor, Prince's Building, 10 Chater Road, Hong Kong (the "Sales Office") from 10:00 a.m. on 22 December 2017 to 2:00 p.m. on 22 December 2017 ("Tender Closing Time").

任何標書必須以標書格式(指定格式)提出，標書連同由投標者簽署的其他有關的投標文件須於 2017 年 12 月 22 日上午 10 時至 2017 年 12 月 22 日下午 2 時(「招標截止時間」)期間，放入一個密封的信封內並投入放置在香港中環遮打道 10 號太子大廈 18 樓(「售樓處」)的指定投標箱內。

Notwithstanding anything herein provided, if typhoon signal no.8 or above is hoisted or black rainstorm warning is issued in Hong Kong at any time between 10:00 a.m. on the day on which the Tender Closing Time falls and the Tender Closing Time, the Tender Closing Time will automatically be postponed to 2:00 p.m. on the next succeeding working day.

即使本銷售安排資料另有規定，如在招標截止時間當日上午 10 時至招標截止時間內的任何時間，8 號或以上颱風訊號在香港懸掛或黑色暴雨警告在香港發出，招標截止時間將自動延至隨後的下一個工作日下午 2 時。

3. If a tender is accepted by the Vendor, the Vendor shall send a written notice of acceptance to the successful tenderer not later than 3 working days after the day on which the Tender Closing Time falls.

Once a tender is accepted, the Form of Tender together with the Vendor's written notice of acceptance shall constitute a binding agreement between the Vendor and the successful tenderer in relation to the sale and purchase of Property on the terms and conditions contained in the Tender Notice, the Form of Tender and Conditions of Sale attached to the Form of Tender.
